Government of Saint Lucia's 91-day Treasury bill Issue

The Government of Saint Lucia's 91-day Treasury bill issue, auctioned on the Regional Government Securities Market using the primary market platform of the Eastern Caribbean Securities Exchange (ECSE), raised \$11.0 million.

Four licensed intermediaries placed a total of 12 bids, ranging from \$5,000 to \$2.4 million, with an aggregate value of \$11.561 million. A competitive uniform price auction methodology was used and the resulting discount rate was 4.750 percent.

The Bank of Nevis Ltd, Bank of St Vincent and the Grenadines, ECFH Global Investment Solutions Ltd and First Citizens Investment Services Limited were the brokers that participated in this auction.
