Summary trading report for the week ending Friday, 21 March 2014

Eastern Caribbean Securities Market

On the Eastern Caribbean Securities Market this week the following securities traded:

- 1,304 East Caribbean Financial Holding Co Ltd shares traded at a low of \$7.00 and at a high of \$7.05, closing at \$7.00 per share; also 31 East Caribbean Financial Holding Co Ltd shares traded odd lot at \$7.00 per share
- 2,757 Grenada Electricity Services Ltd shares traded at a low of \$10.00 and at a high of \$11.00, closing at \$10.00 per share; also, 28 Grenada Electricity Services Ltd shares traded odd lot at \$11.00 per share
- 50,000 St Kitts Nevis and Anguilla National Bank Ltd shares crossed the market
- 2,973 St Lucia Electricity Services Ltd shares traded at a low of \$24.00 and at a high of \$25.00 per share, closing at \$24.00 per share; also 500 St Lucia Electricity Services Ltd shares crossed the market
- 200 Republic Bank (Grenada) Ltd shares traded at \$45.00 per share
- 5,000 units of the Government of Saint Lucia's 6-year US\$ bond, trading symbol FLG060216, traded at 7.0%

Regional Government Securities Market (RGSM)

On the Regional Government Securities Market, the Government of the Commonwealth of Dominica's 91-day Treasury bill auctioned on the ECSE's primary market platform raised \$20.0 million. The competitive uniform price methodology used, resulted in a discount rate of 1.999%.
