1. Business.

Domlec's performance continued to show steady progress in 2003, despite serious financial pressures related to the struggling Dominican economy. The economy of Dominica continued to contract in 2003 and electricity production was down by 2.1 % from 2002 levels. This trend has continued during the early part of 2004. Domlec staff is meeting this challenge by exploring and implementing new ways to make Domlec more efficient. During 2003 tariff increases were zero and Domlec staff numbers were reduced by 9% from year-end 2002. The Improvement Program saw the last of the high cost rental generating units removed from the system and significant progress on the replacement of faulty meters that under record sales.

Income and earnings were somewhat below expectation, primarily due to Domlec under recovering the cost of fuel by \$700,000. In an agreement with the Government of Dominica, Domlec agreed to subsidize the cost of electricity by \$700,000 during the last three months of 2003.

In its budget of June 2003 the Government announced the withdrawal of the duty free concession on fuel to Domlec. This resulted in a 71% hike in the price of fuel and ultimately an increase in the price of electricity. Government and Domlec entered into the agreement of October 2003 to afford customers interim relief pending the review of the Electricity supply Act (ESA). The review, which began in or about November 2003, is ongoing under the guidance of the World Bank and in consultation with Domlec. The first amendment to the Act was passed in Parliament on December 2003and sets performance targets for the utility company. Further amendments are expected and it is anticipated that in the final result the regulatory framework of the electricity industry will be modeled to ensure an adequate and suitable supply of electricity at competitive rates while maintaining the financial viability of the electricity company.

Despite operating in this very difficult environment, the Domlec Board is pleased that Domlec made a profit of \$1.9 million after tax in 2003. With the company continuing to improve, the Domlec Board has declared a modest dividend of \$0.06/share for the year 2003 payable in 2004.

On the 12th day of August 2003 Domlec was listed on the Eastern Caribbean Stock Exchange. Domlec became the first company in Dominica to be listed on the exchange thus raising the profile of Domlec and Dominica in the region. The listing provides Domlec shareholders with a convenient process to buy and sell Domlec shares. Between August 2003 and December 2003, 527 Domlec shares traded at a price of \$2.16. As a listed company, Domlec must comply with the regulations of the Eastern Caribbean Regulatory Commission, and reports to the Commission on a regular basis.

A major meter replacement program took place in 2003 and will continue for several years. Domlec has many old meters that under record customer's consumption. This program led to a 0.5% reduction in losses, and these savings reflect in lower costs for consumers in general as the new meters ensure customers pay for all the power they use.

A new meter service was introduced to Domlec customers in 2003. The new "Pay as You Go" meter technology went into service on a pilot basis in 2003. Nearly 200 of the new meters were introduced in 2003 under the program. In early 2004 Customer Service has received a

significant number of requests for the new technology. The new meters are being offered to all customers at no cost to the customer. Customers can more effectively manage their power usage with this new meter, and can purchase electricity on a weekly or monthly basis as they wish. Customers with rental properties are finding the new technology particularly attractive.

As no debt financing was achieved in 2003, all capital expenditures were funded from cash flow. This has resulted in a number of important projects to both maintain and improve customer service and reduce costs, being deferred. This trend continued into 2004 and caused Domlec management to delay even further, projects to reduce cost and maintain service levels.

During 2003 Domlec commissioned one new 1.6 MW generating unit at Sugar Loaf near Portsmouth. The plan to purchase electricity from an independent power producer did not materialize in 2003 and Domlec proceeded with its back up plan to install a new medium speed generator. Plans were finalized to install a 2.5MW medium speed generator at Sugar Loaf, and requests to the financial community to procure funding were initiated. Due primarily to the uncertainty of the Dominican economy and that of the ongoing review of the Electricity Supply Act, financial arrangements for the new engine were not finalized until late February 2004. Funds from First Caribbean Bank should be available sometime after March 2004 and this new financing will allow Domlec to begin work on its 2004 business objectives.

3. Legal Proceedings. Case

DOMHCV0210 OF 2002 Dominica Electricity Co. V Dominica Geothermal Power Co. Ltd.

- <u>TYPE:</u> Domlec brought a claim against Dominica Geothermal Power Co. for breach of the Power Sales Agreement and the sublicense entered into between the parties and dated 23rd February 1995. Domlec sought declarations that the Defendant had repudiated these agreements and that they should be terminated. The Claimant Domlec also sought a declaration that the Defendant's obligation under the agreement was unaffected by any Force Majeure event.
- <u>Status:</u> Judgment in default of defence was entered against the Defendant on December 9th 2002. On January 4th 2003 the Defendant applied to the court to set aside the judgment and to obtain leave to file a defence out of time. The application was

heard on April 11th 2003 and the Court reserved judgment. The presiding Judge has since retired but no decision was delivered in the matter. The application to set aside the judgement has been resubmitted to the Court and is scheduled to be heard on April 29th 2004.

7. Disclosure about Risk Factors.

Financial assets which potentially subject the company to concentrations of credit risk consist principally of cash, term deposits and trade receivables. The company's cash and term deposits are placed with high credit quality financial institutions. Trade receivables are presented net of the provision for doubtful receivables. Credit risk with respect to trade receivables is limited due to the large number of customers comprising the company's customer base and their dispersion across different economic sectors. Accordingly, the company has no significant concentration of credit risk at December 31 2003.

On December 29th2003 the Parliament of the commonwealth of Dominica passed an amendment to the Electricity Supply Act (ESA). A copy of same was submitted with ECSRC-MC FORM of January 12th 2004. The object of the Amendment is to set performance targets for the utility company.

The amendment is part of the process undertaken by the Government with the assistance of World Bank to review the regulatory framework of the energy industry to ensure an adequate and suitable supply of electricity at competitive rates while maintaining the financial viability of the electricity company.

The amendment to the Act came after a series of consultations between the Government, Domlec and the World Bank. A copy of the World Bank report was also submitted with the above-mentioned ECSRC-MC form in January. The consultative process and the review are ongoing and the parties are expected to resume discussions with a view to completing a comprehensive review of the regulatory framework. Further amendments to the ESA are anticipated

Liquidity

The Company as at the end of the financial year was in the process of negotiating a loan with financial institutions to fund the new generation expansion project. This will provide increased funds to the company during the construction process.

Capital Resources

The company has committed to purchase products and services in the amount of \$1,881,377 (2002 - \$1,984,924) from a number of companies during 2004. Included in this amount is a commitment to purchase goods and services totaling \$574,743 for the rehabilitation of one of its diesel generator sets.

Results of Operations

As part of the economic stabilization and recovery program of the Government of Dominica the duty-free concessions on diesel fuel purchased by Domlec was withdrawn. This resulted in a fuel price increase of over 71% and ultimately an increase in the fuel surcharge and the price of electricity. In an agreement which was entered into between the Government of Dominica and Domlec, the company agreed to absorb EC\$700,000 of the increased cost of fuel. During the 2003 financial year a review of the Electricity Supply Act commenced. The first amendment to the Act, which was passed in Parliament on December 2003, set performance targets for the utility company. Under this amendment the company is required to absorb 2.5% of the current market price of fuel.
